

West Wood Farms Puppy Contract

With the purchase of your new West Wood Farms (WWF) Labrador Retriever I/We agree to the following:

1. If at any time during the life of this pup for any reason you can no longer provide for the well-being of your West Wood Farms Labrador Retriever you will contact us to return your dog and not take your dog to a rescue facility.
2. As an AKC limited registered pup I/we agree to not breeding and spaying the lab (males neutered after 24 months, females after 12 months).
3. Buyer agrees to not bringing their new pup around other dogs until 16 weeks at which point all initial puppy vaccinations have been given.
4. I/We agree to register ownership with AKC and use West Wood or West Wood Farms in the prefix of the AKC registered name.
5. If provided full registration I/We agree to title our dog/bitch with a significant title before breeding and having hips, elbows, eyes certified and appropriate cardiology clearances. DNA testing is cleared by parentage but testing preferred.

8. West Wood Farms guarantees your pup to be healthy and free of illness for 72 hours after the puppy leaves our premises and purchaser agrees to have their vet examine the pup within that time. WWF guarantees the puppy to be free from the genetic diseases that have been tested and cleared on the sire and dam of the litter. We further guarantee your Labrador retriever to have healthy hips, elbows,

and eyes (Note: only disorders that have been tested and cleared on the sire and dam of this litter) for 26 months.

Hip and joint problems can be caused by or influenced by overfeeding, improper diet, failure to maintain proper weight, provide sufficient exercise, over-exercising, or improper exercising.

The guarantee of the hips does not cover problems that are environmentally induced. The purchaser should take great care in bringing up the puppy. The puppy should not be allowed to jump from great heights (for example avoid jumping off a porch or out of a truck) until 12 months or cleared by a vet. This can cause hip dysplasia and elbow problems. WWF will not be responsible for this kind of damage. Should the puppy develop hip dysplasia even after proper care and proper food, then the pup will be replaced with a pup of equal or greater value from the next litter. We will not replace a pup until we have received a copy of the x-rays accompanied by a letter from the vet. This letter should also include proof of regular vet visits that documented a healthy maintained weight up until the diagnosis of HD. After we have reviewed the x-rays, we reserve the right to forward the x-rays to our Vet or to OFA for further evaluation before the pup is replaced. This replacement does not include the cost of transportation or medical-related expenses.

If your veterinarian determines that your puppy has a life threatening illness during the 72 hrs after leaving our premises and has consulted with our vet and confirmed this diagnosis we will refund the purchase price or replace the puppy with a puppy of equal or greater value. At no time will West Wood Farms reimburse a buyer for vet bills.
